Application for New Competency Certificate Required Documents

1. Copies of sponsor's or national partner's passport and UAE ID.
2. Copy of a valid trade licence issued by the Department of Economic Development (or any other relevant Abu Dhabi free zone/specialised area) .
3. Copy of a valid property deed or registered lease contract for the applicant's office and under its name.
4. Copy of a valid Engineer's Registration Certificate (Electricity Wiring Regulation Course E1) for the person named as such in the Competency Certificate Application.
5. Copy of valid Engineer's Registration Certificate for the Solar PV Knowledge Scheme (Once Issued).
6. For each technical staff member named in the Competency Certificate Application:
 - a copy of passport, UAE ID copy and a valid Abu Dhabi residence visa page showing sponsorship of the applicant.
 - Experience record or curriculum Vitae along with references
7. A copy of the notarised Power of Attorney for the applicant's authorised signatory and his/her UAE ID copy.
8. A copy of the notarised Power of Attorney for the Registered Engineer's authorised signatory and his/her UAE ID copy.
9. HSE Certification and Training (at least one staff shall have any of the following certificates):
 - HSEQ certification (e.g., ISO 14001, OHSAS 18001, ISO 9001)
 - Distribution Company HSE certification
 - Personal Protective Equipment (PPE) and training for staff
10. PV Training:
 - List of any Solar PV Integrator training programme by an authorised trainer attended by the applicant staff (provide copies of the certificates).
11. Solar PV experience:
 - Total accumulated solar PV capacity installed to date.
 - List of solar PV experiences available at the staff

Application To Renew/ Change Category / Modify Competency Certificate Required Documents

12. A copy of the previous Competency Certificate issued by the Distribution Company.
13. Summary of the Solar PV Integrator activity in the last 12 months in the field of Solar PV Installation Work.
14. Details of any changes to Contractor technical staff.
15. Details of any address or location change.

Note 1- The Competency Licence must be signed and dated by the applicant's authorised signatory and stamped by the applicant.

Note 2- Originals of all documents required to make a new Competency Certificate Application must be presented at the Approving Committee interview.
